New trends in addressing the drug problem through social crime prevention programs

Presenter: Dr. Xih Guillermo Tenorio Antiga, General Director of Citizen Participation for the Social Prevention of Violence and Crime – Government Secretariat, Mexico.

*As established in the Hemispheric Strategy, the world drug problem is a **complex, dynamic, and multi-causal phenomenon** that includes political, economic, social, and environmental costs, which imposes a challenge to States and their governments. This problem **requires an integrated, balanced, and multidisciplinary response, and in order to provide this, there must be a common and shared sense of responsibility among all sectors and States.** Social prevention of violence and crime as the “a set of public policies, programs, and actions to reduce risk factors that favor the generation of violence and crime, as well as to combat the various causes and factors generated from crime and violence.” It aims to reduce the risk factors that cause criminal behavior and promote the factors that protect against involvement in antisocial or criminal activities, before these behaviors manifest. The social prevention of crime includes actions focused on groups of people that are especially vulnerable to start a path of behaviors associated with crime, such as those that are vulnerable or have a drug problem.*
