**PROPOSAL FROM COMMISSIONER OF GRENADA ON MEM REPORTS**

### Proposal by the Commissioner of Grenada

The Commission mandated that the Sixth Round of the MEM should evaluate the implementation of the Plan of Action (2011-2015) of CICAD's 2010 Hemispheric Drug Strategy.

The Commission will note that the data reflected in the national reports for the Sixth Round is for the period January 2013 to June 2014 while the Plan of Action concludes in 2015. There is therefore a gap in the Sixth evaluation period. In an effort to address this issue, my delegation wishes to propose that supplementary information for the period June 2014 to June 2015 be requested from member states. This will be used to inform the Working Group for the Plan of Action 2016-2020. This is not a continuation of the evaluation process but rather updates on actions taken by member states on the recommendations not completed. My delegation is of the view that this supplementary information is important to retain the integrity of the MEM process in fulfillment of the mandate given by the Commission for the Sixth Round.

In discussion with the Executive Secretariat the following timeline has been drafted in alignment with the approved timeline for the Plan of Action 2016-2020. The full details of this process will be developed in consultation with the Chair and Vice Chair of CICAD, the GEG Coordinator, an Online Working Group and the Executive Secretariat.

This is submitted for your consideration and approval.

### March

- MEM Hemispheric Report
- First draft proposal for the Plan of Action 2016-2020

### April

- **April 1<sup>st</sup> the MEM Section will send a request to the MEM National Coordinating Entities (NCE) of the countries to provide supplementary information for this period of June 1, 2014 – June 1, 2015 to their country reports**
  - **Member states will provide updated information on recommendations deemed not yet completed**
- First draft proposal for the new Plan of Action will be made available for member states revision and comments, before CICAD-57

### May

- Meeting to review 1<sup>st</sup> draft proposal of Plan of Action (before CICAD-57)
- CICAD-57
  - Approval of the MEM Hemispheric Report
  - Presentation and discussion of the 1<sup>st</sup> preliminary draft of the Plan of Action

### June- August

- **June 1<sup>st</sup> deadline for countries to submit supplementary information**
- **The Working Group for the Plan of Action will use the countries' supplementary information in their drafting of said Plan**
- Revision of comments and drafting of the 2<sup>nd</sup> draft of the Plan of Action

### September

- The Working Group for the Plan of Action will meet to revise the said Plan

### October

- Preparation of the final draft for the Plan of Action 2016-2020

- CICAD-58
  - Revision and approval of the new Plan of Action 2016-2020
