1. Site and Date of the Meeting

The LXVI Regular Session of the Inter-American Drug Abuse Control Commission (CICAD) will be held at the Miami Marriott Hotel Biscayne Bay, 1633 North Bayshore Drive Miami, Florida, from Tuesday, November 19th to Thursday, November 21st.

2. Site Visits

The US Government will organize site visits for delegations, which will take place simultaneously on Wednesday November 20th, from 1:30pm – 4:30pm, to the following venues:

- a) Miami Drug Court**
- b) United States Southern Command (SOUTHCOM)**
- c) Miami International Mail Facility/High Intensity Drug Trafficking Area Program**
- d) CBP Facilities at Port Miami combined with USCG Guard Station Miami Cutter Tour**

Further details and information on signing up and security requirements for each site visit will be sent shortly. With the exception of the Miami Drug Court visit, each venue is limited to OAS member states delegations only.

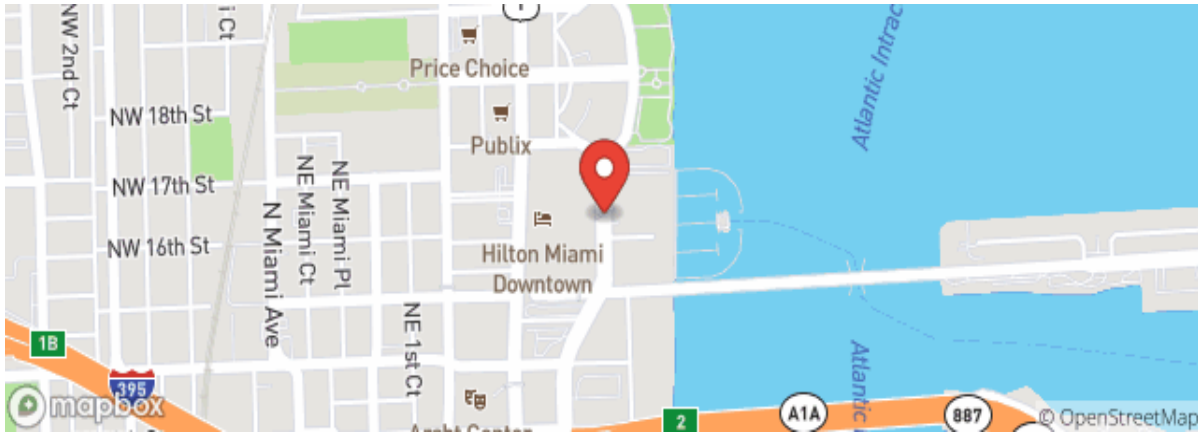

Early registration and pick up of ID badges will take place Monday, November 18th, at the event venue from 3:00 pm. to 7:00 pm. Registration will commence at 8:00 am on Tuesday, November 19th.

For security reasons, ID badges should be displayed throughout the meeting. Delegates will be asked to present an official identification and/or a copy of their official credentials when they register to receive the Conference ID.

7. Breakfast Reception

The United States Government is pleased to host a breakfast reception the morning of Tuesday November 19th, prior to the start of the LXVI Regular Session of the Inter-American Drug Abuse Control Commission (CICAD) from 8:00 a.m. to 9:00 a.m. All delegations are invited.

8. Languages and Documents

The LXVI Regular Session of the Inter-American Drug Abuse Control Commission (CICAD) will be conducted in the four official languages of the OAS: Spanish, English, Portuguese, and French. Simultaneous interpretation services will be provided in those languages.

9. Communications

Wireless Internet will be available at the event venue. Participants will be responsible for paying their domestic and international telephone bills.

10. Entry Requirements

The US Government requires travelers to present a passport, which must have a minimum validity of six months, and a copy of their round-trip ticket. Also, all foreign citizens (except those whose countries are members of the Waiver Program traveling only with a valid passport) need a valid visa to enter the United States. Without the appropriate visa, the immigration service will not allow entry to U.S. territory.

11. Medical Care

Participants are responsible for the costs of any subsequent medical care. It is recommended that participants have insurance with international major medical expense coverage.

12. General information

a. Voltage

The standard voltage is 120V and the frequency is 60Hz.

b. Weather

The average maximum daily temperature in Miami (Florida) in November is between 80 and 83 degrees Fahrenheit (27 to 28 degrees Celsius). The average minimum temperature during the month of November ranges between 66 and 70 °F (19 to 21 °C).

c. Distance from the airport to downtown

Miami International Airport (MIA) is located about 5 miles north of Downtown Miami and 7.3 miles east of Miami Marriott Hotel Biscayne Bay.

d. Transportation to and from hotel

Delegates are responsible for organizing their transportation from Miami airport to their hotel. No transportation will be provided. Average taxi fare to the Miami Marriott Hotel Biscayne Bay is between \$22 and \$25 USD dollars.
